

Special Meeting – Voting Returns

A Special Meeting of the Board of Education of the Northport-East Northport Union Free School District was held on Tuesday evening, May 17, 2016, beginning at 10:11 p.m., in the Cafeteria at the William J. Brosnan School, 158 Laurel Avenue, Northport, New York, with Mr. Andrew Rapiejko, Chairperson, opening the meeting and presiding.

1. President Rapiejko called the meeting to order.

Public attendance: There were approximately 35 persons present.

2. Mr. Rapiejko led those present in the Pledge of Allegiance; and
3. Pointed out the emergency exits.
4. There were no affidavit ballots submitted during the election.
5. Board Counsel John Gross announced the following election results:

Proposition #1 (2016-2017 Budget \$161,380,883)	2,568 Yes	687 No	Approved by 1,881 votes
Proposition #2 (Capital Reserve Expenditure)	2,484 Yes	390 No	Approved by 2,458 votes
Proposition #3 (Reduce # Board Members)	1,881 Yes	1,294 No	Approved by 587 votes

Mr. Gross announced the results of the Trustee elections: Allison Noonan received 2,039 votes; Julia Binger received 1,543 votes; Shawne Albero received 1,410 votes, Andrew Rapiejko received 1,984 votes, and Lori McCue received 1,560 votes. Allison Noonan, Andrew Rapiejko and Lori McCue were elected trustees.

President Rapiejko congratulated the newly elected trustees and thanked all the candidates for running.

6. Motion was made by Trustee Badanes, seconded by Trustee Stein, to approve the following resolution:

6.01 “RESOLVED, that the voting returns for the 2016-2017 Budget Vote, the Election of Trustees, Proposition #2 and Proposition #3 be accepted, subject to certification by the District Clerk”

Unanimously carried.
