5. ANNOUNCEMENTS FROM THE SUPERINTENDENT OF SCHOOLS

Mr. Robert Banzer, Superintendent of Schools, stated that the Board meeting being held this evening is to consider what to do after the results of last Tuesday's election. Mr. Banzer stated that he received a phone call yesterday from Senator Gaughran who notified him that the district was the recipient of a \$1 million allocation from the state because of the significant tax certiorari event. Mr. Banzer thanked Senator Gaughran and all the legislators in the area who have been advocating and fighting for us in this entire process. Mr. Banzer stated that he is recommending that the district present a budget that has a zero percent tax levy increase for the 2021-2022 school year. The tax levy is reduced by \$1.126 million. There is an increase to the assigned fund balance of \$111,265 and \$1 million increase into miscellaneous revenue.

There was a brief discussion about the \$1 million allocation, playgrounds at East Northport Middle School and Northport Middle School, and COVID related expenses.

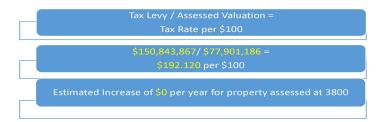

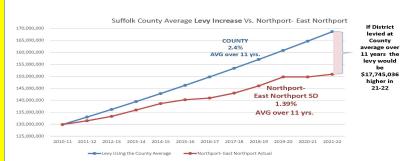

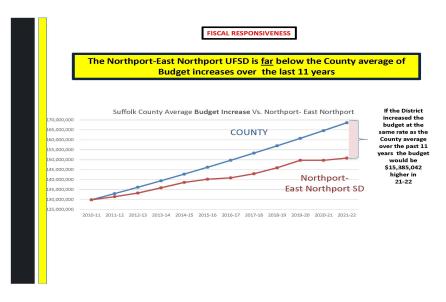

6. PUBLIC COMMENT ON THE 2021-2022 BUDGET - BOARD MOTION TO CONVENE INTO COMMITTEE-OF-THE-WHOLE TO INFORMALLY DISCUSS THE BUDGET

<u>Name</u>	Comment
Joe Sabia	Stated that shutting down schools should have saved millions of dollars and spending \$30k per student is driving people out of the community. The community is being overcharged by the school district.
Doug Roberts	Stated that last Tuesday he sat in a room while people cheered and his kids budget got voted down. A big talking point and concern was a zero percent levy. Mr. Roberts stated it was time to move past this and vote on June 15 th . The district does a great job teaching kids and he hopes with a zero percent levy all can be on board.
Joe Stewart	Stated that he believes the district has tightened its budgets over the last 10 years but not once has the budget been lowered. We are down 1,900 kids and the

budget has to come down at some point. Stated that we don't need two libraries and the Brosnan building should be closed.

Paul Darrigo

Commended the administration for their efforts. He is concerned that from now until 2027 the budget cycle will be more difficult. The Board should be supported when they unanimously say they are proud of the budget put forward. Going forward we need to let the administration deliver the programs and let Board members do what they are supposed to do.

Tammie Topel

Thanked Mr. Banzer for the zero tax levy increase. Stated there is so much money in the budget and reserves. There was no reason to raise the budget in the first place and the budgets can't keep going up. Asked the Board to give the community information regarding things such as Mattinecock Court if they receive correspondence.

Joe Dragone

Stated that the million dollar phone call may not happen again next year and the federal funds are not going to happen either. Thanked the administration and Board for thinking longer term and not one year at a time. Stated as an education professional he would rather depend upon the elected trustees and professionals hired to make long term decisions in the best interest of the homeowners, taxpayers and parents. We are the only district with a tax cap compliant budget that has failed on all of Long Island. Urged the Board to think about the long term interests of the taxpayers of the community and to continue on the glidepath.

Bethany Pokorny

Thanked the Board for preserving the district. The past three years have been difficult and issue after issue has divided us. Now is the time where we must find places of agreement, compromise and acceptance to more forward as a community and start on a path of improvement that is in the best interest of the children. The community needs to know more about programs that make our district different, need to know the opportunities the children have. Moving into the 2021-2022 school year our smallest community members deserve nothing less than everything our schools have to offer which requires our budget to pass.

Nicole Raganella

Stated that in the beginning of the budget season a slide showed the budget would have been \$180 million if we didn't close schools and we were told we would have \$5 million in savings from closing schools. Stated that the Board is tone deaf as people were speaking out against the budget. Asked the Board to start representing the community.

Denise Schwartz

Stated that enough is enough and that the issues over the years were handled poorly. The Board never surveyed the community if they would have listened they would have put up an acceptable budget. Asked where Senator Gaughran's cancer study went. Stated the district wasted \$14 million in legal fees on LIPA and that Mattinecock Court is a big concern and she is worried what the district will do with the Dickinson property.

Shawne Albero

Asked if the district can guarantee that the playgrounds will comply with ADA standards. Stated that not enough emphasis is put on reading and that only 34% of 4th graders are reading at or above New York State levels and asked the district reconsider using balanced literacy. Asked how the district is going to fund the \$86 million needed for capital projects.

Christina Karman

Asked if the transportation hub is still being proposed in the budget and if the budget is remaining the same minus the \$1 million. Stated that the bus depot is a big problem and that the district heard from over 2,000 people saying that something was wrong with the proposed budget but nothing had been done about

Rosanne Fischer

Stated that the original budget did not pass by 167 votes and urged the Board to inform community members as a lot of folks are misinformed. We need to unite the community and educate them on the facts about small class size and per pupil costs. Stated that with a contingency budget there could be potential for things being cut.

Kyle Halm

Commended the administration on a zero tax levy and echoed the statements that we need to come together for the kids. Stated that students who quality for one on one transitional counseling should get it. Stated that the district needs to address the community in acceptance.

Phyllis Clements

Thanked the administration for presenting the budget and stated she was sad to see it voted down. There are many people who support the school district even if they don't have kids. It is important to pass the budget to maintain the integrity and reputation of the community. We need to move forward and maintain a positive outlook for the children in the district.

Julie Hendricks-Atkins Thanked Senator Gaughran for his advocacy on behalf of the district. Thanked Mr. Banzer for his presentation and for the prudent financial planning for the district. Stated that a thoughtful and well planned budget was originally proposed and the \$1 million will alleviate short term concerns. Stated that the last thing the district needs is negative headlines that the community no longer supports it. Stated that community members need to vote yes on the revised budget on June 15th.

Moriah Heuer

Stated that the presentation of a zero percent budget for two years in a row is a mistake. Being the only school district whose budget was voted down that was not facing a super majority vote is a major negative. The vote difference was 167 votes and that is hardly a majority of the community. People need to get out and vote. Stated she is worried about what will happen going forward and if in two or three years will we have to have a budget that will need to pierce the tax cap.

Nicole Richichi

Asked with school ending and the temperatures rising will the students still need to wear masks. Asked if the Pulaski classrooms will be equipped with working air conditions throughout July while the students have to wear masks.

Leigh Boodoo

Thanked Mr. Banzer and Mr. Bonadonna for confirming that no services will be cut due to the lower budget. Stated that as a parent she wanted to speak on comments on the division in the community. As a parent some people need to stop reacting. We need to stop bringing up the divide and talk about how we can move forward.
