7. REFLECTION/SUPERINTENDENT UPDATE

President Licopoli stated that the Board is in the process of shaping the goals for the 2022-2023 school year. The Board will report out to the community in terms of goal setting and projected outcomes. The Board will maintain the committees and will work hard with respect to functioning as a governance team, working toward consensus and being respectful and mindful of the challenges in front of us and the differing perspectives. Never losing sight of the prize which is our students and the education they receive, and social-emotional and academic development.

Superintendent Banzer reflected on graduation and how everything went smoothly. It was great to have it outside and not to worry about the weather. Congratulations to the class of 2022 and their families. Mr. Banzer thanked Mr. Dennis and the high school administration, the teachers, clerical, the custodial and maintenance crew and security. It was a very prideful day and the culmination of a very challenging year.

The summer programs are under way, ESL program, the summer rec program, and the GetSmart Program. A lot going on in the district and things are humming along.

Mr. Howard highlighted the projects underway throughout the district. Three parking lots being worked on - Norwood is getting an expansion, Pulaski is getting an expansion, and resurfacing of the back parking lot at WJB. Various bathrooms are being done at ENMS and Pulaski. The Pulaski main office is receiving a refurbishment. Pulaski is receiving new shades throughout the building, replacing the original shades. There have also been movements within district. The Board recently approved an amendment to lease agreement with Island Kids, and they are renting additional space. The additional space will displace additional departments. Transportation was moved to Dickinson, and Technology and Special Education will be moved to other areas of WJB. Community Services will also be moved to Dickinson and the community will be able to go to programs there. The amendment to the lease with Island Kids will provide an additional \$100k in revenue.

There was a brief discussion regarding moving departments to the high school after the declining enrollment.
