



K-12 Student Attendance By School Year




K-12 Student Enrollment By Building

Demographic Enrollment Breakdown












Academic Coursework Middle School Regents Coursework

Academic Coursework Middle School Regents Demographic Analysis












Academic Coursework District Investigate Program



Belonging and Involvement Attendance


Attendance rates by building (2023-2024 comparison)



- The District is in the fifth year of a seven-year LIPA settlement glidepath payment (2024-25).
- Expenses funded by ARRA/ESSA Grants. (Grants end September 2024)
